**PROVISIONAL ORDER APPOINTING COUNSEL**

The cause having come before the Court, and that the defendant has requested to be found indigent pursuant to Sec.27.52, F.S.S. The Court understands that the defendant's affidavit for indigent status is still under review pursuant to Sec.27.52 F.S.S. ( ) It is therefore provisionally ORDERED that the Public Defender (or Conflict Attorney \_\_\_\_\_) is appointed pending final determination of indigent status. Defendant is hereby ordered to pay a \$50 application fee for appointment of counsel. Officials of the Osceola County Jail are hereby ordered to deduct \$50 from the defendant's jail account. If funds are not available at this time, the defendant has two (2) weeks from this date to deposit \$50 into said account or with the Clerk of Court. The Jail or the Clerk must be provided with the name of the defendant and the case number to which the deposit applies.
